- 5. This agreement includes your participation as a driver or as a passenger of the Monterey Scenic Drive on Saturday July 15, 2023.
- 1) PARTIES INCLUDED The participant understands that this agreement includes Concorso Italiano Inc., Concorso Italiano Foundation, its sponsors, affiliates, hosts, venues, municipalities and government agencies, as well as all partners, employees, directors, officers, and agents, whether paid or volunteers, and the owner of the structure(s) and/or land utilized for hosting the event activities, and the benefactor Habitat for Humanity (hereinafter collectively referred to in this agreement as Concorso Italiano).
- **2) PARTICIPANT** the participant means the driver of a vehicle participating in the Monterey Scenic Drive event or a passenger of any vehicle participating directly or indirectly in the event.
- 3) ASSUMPTION OF RISK The participant is fully aware that driving in winding hills and or mountainous roads, farmland roads that may have slow moving vehicles, and/or farm equipment, 2 lane roads, and all associated activities are inherently dangerous and contain inherent risks and dangers (including serious injury or death), that no amount of care, caution, instruction, or expertise can completely eliminate. The participant knows and understands that the participant alone is fully responsible for every aspect of the drive. The participant knows and understands the scope, nature, and extent of the risks involved in the activities contemplated by his/her agreement. The participant voluntarily, freely, and unconditionally chooses to incur any and all such risks and dangers.
- 4) EXEMPTION FROM LIABILITY The participant hereby fully and forever discharges and releases Concorso Italiano from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of any damages, both in law and in equity, in any activities including not only the participants actual driving but any activity the participant engages in before, during and after participating, or resulting from the negligence of Concorso Italiano or from any other cause or causes.

- 5) COVENANT NOT TO SUE The participant agrees, for him/herself and his/her heirs, executors, administrators, distributes, guardians, legal representatives, or assigns, as well as all passengers and the passenger's heirs, executors, administrators, distributes, guardians, legal representatives, or assigns, not to institute any suit or action at law, or otherwise, against Concorso Italiano, nor to initiate or assist the prosecution of any claim for damages, or cause of action, which the participant, his/her heirs, executors, or administrators hereafter may have by reason of injury to the person of the participant or to his/her property arising from the activities contemplated by this agreement.
- 6) INDEMNITY AGREEMENT The participant agrees unconditionally, for him/herself and his/her heirs, executors, administrators, distributes, guardians, legal representatives, or assigns and for all passengers heirs, executors, administrators, distributes, guardians, legal representatives, or assigns, to indemnify and hold harmless Concorso Italiano from any and all losses, claims, actions, or proceedings of any kind which may be counsel fees incurred by Concorso Italiano, the participant, and indemnified parties, or any of them, for the defense of any such actions which may hereafter arise directly or indirectly from the activities of the participant while engaging in activities contemplated by this agreement.
- 7) CONTINUATION OF OBLIGATIONS The participant agrees and acknowledges that the terms and conditions of the above provisions, including ASSUMPTION OF RISK, EXEMPTION FROM LIABILITY, COVENANT NOT TO SUE, and INDEMNITY AGREEMENT shall continue in full force. The agreement shall be effective not only for the participant's first activity but for any and all activities in any way associated with Concorso Italiano.
- **8) PHOTOGRAPHIC MODEL AGREEMENT** I authorize Concorso Italiano to use and reproduce any photographs, video, digital images of any kind, taken of me participating in the drive, including before and after components, for advertising, promotion, or any other purpose whatsoever, and hereby waive all claims or rights arising out of such use or reproduction.
- **9) MODIFICATION AGREEMENT** This agreement cannot be modified orally and a waiver of any provision shall not be construed as a modification of any provision herein, as a consent to any other provision herein, or as a consent to any subsequent waiver or modification.
- **10) HEALTH CAPABILITIES** The participant currently has no physical or mental condition that impairs his/her capability and the participant is fit to fully participate in all drives and activities associated with the drive activities.
